Dear Texas Vehicle Dealers and Manufacturers,

The Sheriffs' Association of Texas (SAT) invites interested bidders to submit bid proposals for the 2023-2024 Vehicle Procurement Program under Bid 24-05-1010. We look forward to working with Ford, General Motors, and Stellantis dealers within Texas this upcoming year. Without your support and participation, this program would not be possible.

There will be three contract numbers for the 2023-2024 contract year – Bid 22-03-1008RR, Bid 23-04-1011R and Bid 24-05-1010. Bid 22-03-1008RR and Bid 23-04-1011R will consist of all current contracts that will extend for one additional year upon mutual agreement beginning November 1, 2023. Bid 24-05-1010 will consist of all vehicles not currently on contract or extending for one additional year.

The SAT will list out all available base and option vehicle models within our online bidding system, VendorLink under Bid 24-05-1010. One base model per vehicle type per manufacturer will be selected. Additional models per vehicle type will be offered as a downgrade option or upgrade option within the base model. The first draft bid package will be available in VendorLink on August 2, 2023, for your review.
